## Agenda Items:

- i. Discussion: FA22 Charge re. Academic Probation Requirements
- ii. Review of voting options:
  - ii.1. Leave as is limiting participation in all things extracurricular
    - "Students on probation are not permitted to engage in extracurricular activities such as HCC clubs or intercollegiate athletics."
  - ii.2. Focus on limiting leadership roles only in both and change to -
    - "Students on probation are not permitted to engage in leadership roles in extracurricular activities such as HCC clubs or intercollegiate athletics"
  - ii.3. Focus on limiting leadership roles only in clubs only and change to -
    - "Students on probation are not permitted to engage in leadership roles in HCC club and are not permitted to engage intercollegiate athletics"
  - ii.4. Focus on limiting leadership roles in athletics only and change to -
    - "Students on probation are not permitted to engage in extracurricular activities such as HCC clubs and are not permitted to engage in leadership roles in intercollegiate athletics"
  - ii.5. Remove the line completely from the Catalog leaving Academic Probation status with zero impact on co-curricular student participation in clubs and athletics.
- iii. Vote need a quorum:
  - o Quorum met; Vote needed on FA22 Charge re: Academic Probation Requirements.
  - Group questions; What is the NJCAA and are they a valid group providing the best standards? Should HCC have higher standards than what is presented by NJCAA?
  - Group discussion; NJCAA is THE governing board, setting the National Standards; each college can adapt standards as needed. Higher standards are always a good thing however we don't need two sets of standards.
  - Group discussion; Narrow voting options down to items ii2 and ii3. However, clarification on wording is needed for items ii2 and ii3.
  - Christine provided clarification on wording for items ii2 and ii3.

- Item ii.2: Students on academic probation are not permitted to engage in leadership roles in HCC clubs or in leadership roles on HCC intercollegiate athletic teams.
- Item ii.3: Students on academic probation are not permitted to engage in leadership roles in HCC clubs. Students on academic probation are not permitted to participate in intercollegiate athletic teams.
- Voting: Committee voted 7 to 1 to change the Academic Probation Requirements to read;
  - $\circ$  ii2 7 votes
  - $\circ$  ii3 1 vote
  - Students on academic probation are not permitted to engage in leadership roles in HCC clubs or in leadership roles on HCC intercollegiate athletic teams.
- This change will be made beginning with the FY24 catalog.

Academic Probation

Students are placed on academic probation if their total cumulative grade-point average is at least:

1.0 but less than 1.7 after 15 attempted credits

1.7 but less than 1.8 after 30 attempted credits

1.8 but less than 1.9 after 42 attempted credits

1.9 but less than 2.0 after 56 attempted credits

Students on probation are not permitted to carry more than 15 semester hours. Students on probation are not permitted to engage in extracurricular activities such as HCC clubs or intercollegiate athletics. A student on probation is not allowed to register on Self-Service and must meet with an academic advisor/ retention specialist in person.

Developmental courses are not considered college level courses and cannot satisfy graduation requirements. However, developmental courses are counted in the total cumulative quality point average to determine academic probation.
