Student Government Association

Assistant Professor Schwartz reported on faculty topics including upcoming program reviews and having a small working group revise the faculty constitution.

President's Report

Foundation Report

Senior Director Whaley gave a report on the Foundation. Some topics included: 118% of foundation goal has been met at this time, Flower and Garden Show will be held Saturday, March 16th – Sunday, March 17th, June 12th will be the foundation board annual meeting, and August 12th will be the foundation board retreat that the Trustees are welcome to attend.

Financial Report as of January 31, 2024 (ACTION)

Vice President Soeffker-Culicerto summarized the financial report for the period ending January 31, 2024. Ms. Lampton moved to accept the financial report as submitted. Ms. Brooks seconded, and the motion carried by unanimous vote.

Special Reports

Student Financial Assistance Report for 2022-2023

Dean Ohl-Gigliotti discussed the Student Financial Assistance Report. There was a decrease of \$3,851,045 financial aid awarded from FY22 to FY23. In FY23, there was an increase of Federal Grants Non-Title IV, Miscellaneous aid, and the student workforce.

Distance Learning Report

Dean Beache shared a video for the Distance Learning Report. She reported on improved accessibility with D2L. Also there has been a growth of General Education course becoming QM certified including RDG-095, GDT-143, IST-123, WEB-101, and EDU-114. The college has updated the timeline for completion of master classrooms and QM certifications. In January 2024, there was an 83% increase of master classrooms. Dean Beache also passed out a pamphlet for the Trustees that discussing QM certification.

Credit and Non-Credit Enrollment Report

Director Crawford reported on credit enrollment. Enrollment for Out-of-State students continues to rise. Veteran enrollment is up 15% over the last three years. Maryland Blueprint enrollment numbers are great. HCC's Nursing program enrollment has decreased slightly since 2020. Application numbers are looking good as well.

Dean Shank reported on non-credit enrollment. FTE is up from last year which was already an impressive year. The department has been partnering with organizations to increase enrollment. The biggest enrollment contributing group is Adult Basic Education.

New Business

Revision of Policy 4040 (ACTION)

President Klauber shared that HB384, effective July 1, 2023, prohibits Maryland Colleges from withholding transcripts because the student owes a debt to the College. The college has changed our practice over the summer but did not realize it was not taken from the written policy until after the Board approved the changes to Policy 4040 – Code of Student Conduct in January

2024. Mr. Abraham moved to remove the word "transcripts" from section I under Sanctions in Policy 4040. Mr. Newcomer seconded, and the motion carried by unanimous vote.
