- II. Approval of April 25, 2024 Meeting Minutes Kathy make a motion to approve, Chis seconded. It was approved with four abstentions who were not present in the last meeting.
- III. Charge #1 Review Current Course Load Policy: Maximum Summer Course Load
 - a. College Catalog: Academic Policies/Course Load
 The normal maximum course load for a full-time student who is not on probation
 is 18 semester hours of credit. The number of class hours will vary according to
 the number of laboratory courses in the program. Students, full- or part-time with
 a cumulative average of "B" or better at HCC, may, with the consent of the
 Director of Advising, Registration and Student Support, take credit hours in
 excess of 18.
 - b. Chris gave background on the motion especially pertaining to summer and overlapping terms.
 - c. Tom asked for the success rate of non-trucking students.
 - d. Tracy mentioned that often four-year college students take summer classes.
 - e. Brenda said there are no financial aid caps for the summer.
