2. COMAR Regulation Update for Substantial Program Change Notifications to MHEC

COMAR released a new regulation that requires an MHEC substantial notification to now be sent for a "Change more than 50 percent of an existing program's course work, unless all of the proposed changes are required by an accreditor, licensing board, or other state or national entity that governs academic program elements required to enter into a particular field or industry" stead of the previous 33 percent. MHEC has yet to update their website with this new regulation and supply us more instruction.
